- ii. Members are not happy with the new proposed route for FP17. A green path in the countryside has now been converted into a completely hardstanding path through the development that does not appear to go anywhere.
- iii. Members would like reassurance that the proposed driveways are long enough that 2 cars parked in front of each other may park on them without overhanging the footpaths.

As a result of the above, this application is in contravention of Policy PC5 (Footpaths and Cycleways) of the Sandbach Neighbourhood Development Plan (2022)

- i. Members are disappointed to see that the Capricorn is yet to provide any employment and believe that this application is premature int hat respect. Employment should be delivered before any further houses.
- ii. Members are disappointed that there is no access to this site through Capricorn. This places further additional stress on Heath Road, where the access is too narrow for bin wagons etc.
- iii. Members are disappointed to see that there is no vehicle access to rear gardens on Heath Road and consider this a missed opportunity. Furthermore, Members note that they are yet to see any sort of legal agreement regarding the transfer of parking from Wrights Lane onto the spaces on the site.
- iv. Members would not like to see construction traffic coming down Heath Road, and should instead access the site from Newcastle Road for safety reasons.
- v. There is no allocate visitor parking within the development. Members would welcome visitor parking in the space next to the Pumping Station.
- vi. Members would like to see conditions to ensure the retention of trees once the development is completed.
- vii. Members would like reassurance that the proposed driveways are long enough that 2 cars parked in front of each other may park on them without overhanging the footpaths.
- viii. It isn't clear in the application how overlooked the green spaces are. They shouldn't be hidden from view so as not to encourage antisocial behaviour. The Green spaces may be overlooked by Capricorn, although this isn't clear from the application.

Despite the above, Members welcome the 8 affordable homes proposed on the site and hope that this number doesn't reduce, as it has on developments elsewhere in Sandbach.

Dear All,

During the winter of 2021/22, Cheshire East Borough Council implemented new winter gritting routes. These routes were developed following the introduction of the new highway maintenance guidance document Well Managed Highway Infrastructure (WMHI) and as such the routes were developed following the guidance in WMHI. The new routes involved new roads being added to the treatment network and also roads which no longer achieved a minimum risk based score being removed.

On the 2<sup>nd</sup> March 2022 the Council's Highways and Transport Committee considered a paper which outlined the end of season review that is being undertaken to understand the success of the new routes and any amendments that may be required. As part of this paper there was a proposal to engage with the Town and Parish Councils in the Borough to understand if they would like to fund additional 'top up' gritting in their areas.

The attached survey proforma and supporting information pack is the start of this engagement and outlines the conditions that would be associated with the purchase of additional top up gritting, together with a calculation of the approximate costs of this service based on data inputted. I would like to bring to your attention the following key points;

- Timing of implementation of any gritting routes will be subject to the levels of interest expressed in the 'top up' service.
- The estimated cost calculator is based on an assumed level of take up. Final standing costs
  and costs per treatment will be indicated once the initial level of interest has been
  ascertained. Therefore these should be considered as a guide for costs in year 1 of the
  service.
- The final costs will be subject to annual inflationary increases over the minimum service period.
- A legal agreement will be required which will set out within it a minimum Duration of Service.

Please can you complete the attached form and return it to the email address <a href="mailto:iandh@cheshireeast.gov.uk">iandh@cheshireeast.gov.uk</a> by no later than 5pm on Friday 27th May. If no response is received then it will be assumed that the Council in question does not wish to take part in any potential winter gritting 'top up' scheme. The results of the survey together with any recommendations will be included as part of a forthcoming report to the Council's Highways and Transport Committee.

### CHESHIRE EAST BOROUGH COUNCIL (PROHIBITION AND RESTRICTION OF WAITING, LOADING, STOPPING AND STREET PARKING PLACES) (VARIOUS ROADS) (CONSOLIDATION) ORDER 2022

### STATEMENT OF REASONS

### **Effect**

The effect of the proposed Order will be to revoke all the existing all prohibition and restriction of waiting, loading, stopping and street parking places in Cheshire East and then re-enact the provisions of those Orders into one consolidated Order for waiting, loading, stopping and street parking places in Cheshire East.

### Reasons

Currently details for all static traffic restrictions such as the prohibition and restriction of waiting, loading and street parking places throughout the Cheshire East area are stored as paper copies. Under current legislation, Cheshire East Council not only has an obligation to introduce static traffic restrictions in order to ensure the safe and efficient movement of road users on its highway network, but it should also ensure that its Traffic Regulation Orders (TRO's) are systematically reviewed and maintained so that they conform to current legislation.

With the advancement of digital and online technology, this system of record keeping has become outdated and due to the large quantity of TRO's which have been made over a number of years, it can also be time consuming to locate relevant orders which are either current or have at some point been superseded.

In view of these difficulties, the decision has recently been taken to produce a new TRO for static traffic restrictions on the Cheshire East road network, which will effectively consolidate all existing restrictions as one new TRO. This process will provide the foundations for creating a base TRO which can be placed on a computer software programme, specially developed for creating map-based information for current and proposed restrictions, along with details of previous restrictions which have subsequently been replaced or removed. It should be noted that there are no proposed changes to current restrictions in this new TRO, it is just a consolidation of existing restrictions which are already in place on the road network.

Having access to TRO information through this map-based system will also provide the addition benefit of enabling members of the public and the police and enforcement team to access up-to-date information, via the internet, on all existing and proposed restrictions.

In summary this Traffic Regulation Order is proposed to improve and provide access to up-todate information on moving traffic restrictions on the Cheshire East road network by recording details of all approved TRO's on a computer software programme, specially developed for creating map-based records of current and proposed restrictions.
