The meeting was held remotely via Zoom.

#### 1. APOLOGIES FOR ABSENCE

#### 2. DECLARATIONS OF INTEREST

The Clerk of the meeting declared a non-pecuniary interest in application 20/5083C due to the applicant being known to him. The Acting Town Clerk took over clerking the meeting for the application.

The Chair adjourned the Meeting to allow questions from the Member of public in attendance.

Matthias Bunte of Cycling UK summarised to the Committee all the points he has made both in his attached correspondence under items 5 (2 Way cycle Lane on Middlewich Road) and 7.1.

Cllr Hovey confirmed that an email had been received from Cllr L Crane of CEC (also circulated to Committee Members) stating that CEC would be changing the new Cycle Lane on Middlewich Road to 1 way by using simpler wands and recycling the existing wands into other schemes so that materials are not wasted. Also, the parking bays on the Western side of the road will be brought back into service. This is as a result of points raised since the scheme was initially installed.

A member of the public noted that Matthias' view is one sided, with many that do not share the view on social media. The member of public had the following queries and points:

- What measurements of cycling activity were taken on this stretch of road prior to installation.
- What cost benefit analysis was done to ensure added value?
- What uplift in cycling was considered a success?
- What ongoing monitoring is being done?
- Exits onto a blind junction at roundabout and makes road too narrow for HGVS and emergency vehicles to pass.
- Why is it contraflow?
- A lot of parking spaces has been lost which is useful for local residents.
- What has been achieved by introducing the cycle lane it is already a quiet road. Many cyclists on social media say that they won't use it.
- Aesthetically it looks a mess and a lot of tax payer money appears to have been wasted if bollards are now to be lifted.

The Chair noted that most of these points had been addressed in Cllr L Crane's email.

Another resident agreed with the previous speakers comments and noted the money could have been better spent elsewhere. He also highlighted that the cycle lane is not helpful for disabled residents.

The Chair pointed out that the Town Council is only a consultee, the actual work is carried out by Cheshire East Council using funding from central government that had to be spent in a short period of time.

A further resident raised the issue of the 20mph speed limits in and around Sandbach. Questioned why speed limits had been put in around Sandbach whilst having missed some of the most dangerous areas in the process, for example, Ettiley Heath. Cllr Hovey confirmed that it was only a Town Centre scheme, but suggested writing to Cheshire East Highways highlighting the need for a 20mph speed limit on Abbey Road.

Cllr Corcoran commented on the Old Middlewich Road scheme and said he had mixed views about the wands. Whilst they cause issues for drivers, they do make cyclists feel safe. He agrees that costs have been high for the scheme, although this is in part due to a contract CEC have entered into with Ringway Jacobs.

Cllr Corcoran also noted the Parking consultation item and suggested the Parking Strategy put together in 2009 by the Town Council either be put forward as a response or form the basis of a response.

As there were no more questions, the meeting was immediately reconvened.

Members had several strong concerns regarding the 2 Way Cycle Lane, including the impact on business along that stretch who have subsequently complained and the fact that the cycle lane is too wide and not helpful in its current guise. Furthermore, it was noted that the cycle lane does not join up to anything and is taking away parking from an area of town where it is desperately needed. In addition to this, elderly residents in Sandbach must use private vehicles due to poor Transport links in the area. It was suggested that some of the bays should be market as disabled to help with this issue.

Cllr Jack proposed that Sandbach Town Council object to the installation of this project with it being scrapped immediately. Furthermore the disabled bays.

parking bays and original advisory cycle lane on the site should be reinstated. The proposal was not seconded.

Cllr Flavell proposed that the Committee accept the amendments to turn the cycle lane into a single lane, which have been suggested by Cllr L Crane, but also to suggest that some of the bays on the opposite side of the road should be made disabled. The two AQMAs for Sandbach are Middlewich Road and around J17, neither of the measures proposed in 2018 SAND1 and SAND2 reviewing traffic flows and priorities at the Ashfields junction and a vehicle weight restriction on the road appear in the report ever to have been "planned," "implemented" or "progressed", with no "estimated completion date".

I am writing to advise you that Cheshire East Council has produced a draft new Tenancy Strategy, which is an update of the 2012 Tenancy Strategy. Approval has been given by Cheshire East Cabinet to commence the consultation process.

The new Strategy has been developed following engagement with Registered Housing Providers and outlines Cheshire East Council's preference for Registered Housing Providers operating within Cheshire East to use long - term tenancies, with the use of shorter, fixed - term tenancies as the exception, as part of a neighbourhood regeneration / asset management project, for example. Introductory or Starter tenancies which end successfully should normally be converted into Lifetime tenancies.

Cheshire East Council is carrying out a 12 week consultation on the draft Tenancy Strategy between 26<sup>th</sup> October 2020 and 18<sup>th</sup> January 2021.

## Cheshire East Council launches consultations on transport and parking

Cheshire East Council has launched public consultations on local transport and parking plans across the borough.

The consultations, which begin today and end on 31 January 2021, will seek to engage with communities, towns, elected members and stakeholders.

The results of this exercise will inform the future direction of how to improve transport, walking and cycling in our towns. It will also inform proposals, which would be subject to further consultation, regarding changes to parking provision and potential changes to car parking charges in the borough.

The local transport plan consultations are based around the following themes:

- Accessibility for all considering all travel needs;
- Sustainability improving walking, cycling and public transport;
- Quality of the public realm managing traffic to support town centres and the visitor economy;
- Better neighbourhoods improving amenities where people live; and
- Connectivity the strategic links needed to access work, education and essential services, such as hospitals.

Councillor Craig Browne, deputy leader of Cheshire East Council, said: "This consultation is an opportunity for us to work together and get the right blend of local transport provision in the right places.

"Alongside these plans, we are also developing town centre vitality plans for our key service centres, helping us to better understand and respond to local needs.

"We must also consider the potential longer-term impacts of Covid-19. This may include using our spaces differently to enable social distancing, more reliance on active travel and public transport, as well as increased home working."

The car parking consultation looks at:

- The role of parking in accessing town centres (current and future);
- The level of parking charges in Cheshire East and scope for harmonisation;
- · On-street parking restrictions; and
- Improving parking services.

Councillor Laura Crane, Cheshire East Council cabinet members for highways and waste, said: "The local transport plan sets out a need for greater harmonisation of parking arrangements across Cheshire East, during the period 2020 to 2025.

"The parking consultation, alongside the development of town vitality plans, will engage many stakeholders to ensure we have a broad strategy moving forward, taking into account the economic, environmental and community elements that car parking brings."

The responses to the consultations will be used to shape policies and proposals going forward.

Thank you for your email and I note the contents.

If I may I would just like to address some of the concerns you have raised.

We would continue to monitor within the area, we are not removing all of the monitoring tubes, there will be a single diffusion tube at the location that is currently providing us with the highest NO<sub>2</sub> reading. Tube locations are reviewed regularly to ensure they are placed in appropriate locations.

Even if the AQMA is revoked, the actions associated with it will be taken forward as we are obligated to ensure they are. Indeed a review was conducted into the traffic light phasing of the lights on the junction with Ashfields Way (SAND 1) and the outcome of this will be followed through with even if the AQMA is revoked. It is a view of ours that we don't stop trying to improve the air quality in an area just because the concentrations have fallen back below the objectives. There is no guarantee that SAND 2 will be implemented as it may be found that a weight restriction is not feasible for Middlewich Road for all manner of reasons. From initial discussions with Highway colleagues, weight limits do not apply to delivery vehicles in the area, so we would need evidence that there was a large amount of through traffic over 7.5tonnes, as otherwise the weight limit would have no impact.

In terms of GN9 and NOx busting paint, as we reported in our <u>2020 Annual Status Report</u>, this has been put on hold whilst we are awaiting the outcome of further research into the possible impacts of using the paint. You can also see from the same report on page 26 we give an update on the actions SAND1 and SAND2.

I hope this goes some way to alleviate your concerns.

Dear Ann,

Could this please be included in the notes for the next Planning Meeting?

On reading the Sandbach Chronicle report on the Planning meeting on 9<sup>th</sup> December, one of the objections to the cycle lane was that the new cycle lane "did not join up with anything." Whilst the debate has been had, I think it would be helpful just to clarify this. Old Middlewich Road connects Hightown, Sandbach town centre, and, going further, Sandbach Heath to Ashfields PCT, by way of the pedestrian crossing, which means walking the bike across Middlewich Road, which is no great inconvenience. This is my normal route to Ashfields/Aldi and I regularly use it, it is far safer than cycling round the Crewe Road roundabout. I believe that the cycle lane is not aimed at "cyclists" per se (lycra and £1,000 racing bikes), but at people wearing normal clothes who use their bikes as a mode of transport, or are on the verge of doing so. This email is not aimed at the pros and cons of the cycle lane, but to point out that Old Middlewich Road is indeed an important connecting route when travelling to Ashfields. A minor point, perhaps, but such misconceptions could affect important decisions. There will be further debates, no doubt, on further infrastructure changes aimed at making people feel safer on their bikes, and my concern is that decisions could be made based on just this sort of misconception.

Item 5: Elworth, Elton Crossings Road, crossing Salt Line Way to (the old part of) Moston Road

\* crossing for cyclists, i.e. ropped kerbs in 'desire line'; removal/realignment of bollards

Item 7: Elworth, Dean Close to Vicarage Lane

\* upgrade for cycle use

Not mentioned on the Sandbach town cycling plan: junction of Station road with Moss Lane: \* reduce speed of cars and especially lorries making Ih turn from Moss Lane on to Station Road

8. Are there any other options under this objective that we could look into that have not been identified?

Sandbach town cycling plan:

Item 3: Elworth, Marsh Green Road to Bradwall, Wood Lane, (Sandbach FP 36/Bradwall FP 3)

- \* upgrade for cycle use,
- \* surfacing, potentially small bridge in the middle to cross brook

item 14: Sandbach and Wheelock, Crewe Road

- \* continuous cycle lane on both sides of road
- \* at "pinch points" remove centre white line, signing indicating traffic priority from one direction and give way for the other direction

Item 16: Sandbach, Offley Road to Bradwall Road, Sandbach FP 6, via Sandbach Rugby Union Club

\* upgrade for cycle use,


\* extend proposed pedestrian connection to cyclists too

#### 1. New footpath/cycle route to the western side of the development




I would be interested in further details as this is a 'full planning' application. the planning Statement mentions 'A new shared footpath and cycle line (sic) is proposed which will connect to the existing Public Right of Way to the north (Public Footpath Sandbach No.11) and new footpath which forms part of the residential development to the south.'

- FP 11 I believe lies to the west
- how does it connect at the north-western end? I would welcome continuation for cycling via FP11 across Old Mill road to Alderley close or Swettenham Close. This is an aspiration of the Sandbach Town Cycling Plan, item 27, page 14
- how does it connect at the south-eastern ends where it could join up with FP14 to Church Lane? This is an aspiration of the Sandbach Town Cycling Plan, appendix 1, Capricorn, Section E, - recommendations, paragraphs 2 and 3.
- how does it connect to the properties on the south west side? I would like to see connectivity for cycling throughout the sites.
- the surface for the cycle route preferably be tarmac
- minimum, effective width to be 3metres, unaffected by street furniture
- · the legal status for cycling should be clarified
- signposting to indicate that cycling is allowed (see also Cheshire East Cycling Strategy, Cycle-Proofing Toolkit, Submission and Consultation Stage: 'Are the proposed pedestrian and cycle connections legible and include signage between the site and local facilities?')
- I suggest to add all the above details as planning conditions.

#### 2. Cycle parking

The Sheffield type racks should be installed as per specification in the local authority's design guide.

Figure DG19 Sheffield stand - inset 'toast rack' type. Sheffield stands can accommodate two cycles provided that stands are placed 1m apart and at least 500mm from any wall.
