General Power of Competence (GPoC) and Local Council Award Scheme (LCAS)

The General Power of Competence grants local authorities and certain other types of bodies in England, local authorities in Wales, and local authorities in Northern Ireland the ability to do "anything that individuals generally may do."

The key points are as follows:

The GPC was introduced by the Localism Act 2011 and took effect in February 2012;

It allows local councils (including district, county, and unitary councils) to act similarly to individuals, as long as their actions don't violate other laws;

Freedom: Local councils no longer need to search for specific powers to act. GPC gives them the power to do anything an individual can do:

Examples:

- A local council can run a community shop or post office (similar to what an individual can do)
- It can set up a company to provide a service

Limitations:

- Some actions (e.g., creating byelaws, raising a precept, issuing fixed penalty notices) require specific original legislation
- Delegating decisions to individual councillors remains a procedural matter enshrined in law

Encouragement: The government hopes that GPC gives local councils confidence to act for their their communities, providing cost-effective services and facilities;

Scope: Local councils can undertake activities using GPC anywhere, not just within the parish;

In order to qualify to use the Power, councils must demonstrate that they are eligible so to do.

Eligibility is shown by having:

(1) a qualified Clerk,

(2) at least two thirds of the members have stood for election, and

(3)the council has resolved at the relevant annual meeting that it meets those conditions.

Local Council Award Scheme

This Scheme is run by the National Association of Local Councils (NALC) for the following purpose:

'THE LOCAL COUNCIL AWARD SCHEME EXISTS TO CELEBRATE THE SUCCESSES OF THE VERY BEST LOCAL COUNCILS, AND TO PROVIDE A FRAMEWORK TO SUPPORT ALL LOCAL COUNCILS TO MEET THEIR FULL POTENTIAL'

Councils can apply for Foundation, Quality and Quality Gold levels.

The Council is now eligible to apply for the LCAS at Quality Level, and it is recommended that this is achieved by the end of the calendar year. The scheme requires the Council to formally resolve that all documents are prepared to the required standard, once it is ready to make the submission and this will be brought to a future Council meeting. Quality Gold should be an aspiration for the Council the following year.

Achievement of these awards should provide assurance to all parties that the Council is a well managed organisation.
